Replacement of internal plaster ceilings to the north aisle. Masonry repair, re-pointing, lead weathering of side parapets and gable parapets. Internal re-plastering to north aisle as necessary.

Internal re-ordering of the nave including works pursuant to a Temporary Minor Reordering Licence for the removal and disposal of the pews to the north and south of the nave, leaving a central section of pews and replace with wooden Alpha Furnishing 'Jacob' chairs. Introducing four chair trolleys in storage area next to the organ. Replacing the existing carpet in the aisle and dais with a new blue carpet. The relocation of two radiators.

Replacing the existing kitchen by removing the existing partition and storage cupboard, extending the area of the kitchen into the nave and fitting a new hardwood partition with two access doors and servery hatch. Fitting a new commercial kitchen with ventilation.
